Reliance Industrial Infrastructure Limited ('RIIL') today reported its financial performance for the quarter ended 30^{th} June 2017.

Highlights of the un-audited financial results as compared to the previous year are:

FINANCIAL PERFORMANCE AND ANALYSIS

- During the quarter ended 30th June, 2017, RIIL achieved Total Revenue of ₹ 2,482 lakh as compared to ₹ 2,628 Lakh achieved in the corresponding period of the previous year.
- During the quarter ended 30th June, 2017:
 - Income from Product Transportation Service increased from ₹ 635 lakh to ₹ 741 lakh on Y-o-Y basis.
 - o Income from Hiring Construction Machineries increased marginally from ₹ 879 lakh to ₹ 880 lakh on Y-o-Y basis.
 - o Income from Other Support Services increased marginally from ₹ 323 lakh to ₹ 328 lakh on Y-o-Y basis.

Net Profit during the quarter ended June 30, 2017 was ₹ 184 Lakh as compared to ₹ 302 Lakh on Y-o-Y basis.



RIIL continues to provide infrastructure support services namely transportation of petroleum products and water through pipelines, construction machinery on hire, and other support services to Reliance Industries Group, with a substantial portion provided to Reliance Industries Limited.

RIIL presently does not have any expansion plan on the anvil.
