FINANCIAL PERFORMANCE AND ANALYSIS

- During the nine months ended December 31, 2016, RIIL achieved Total Revenue of ₹ 7,793 lakh, an increase of 2.9%, as compared to ₹ 7,575 lakh achieved in the corresponding quarter.
- During the nine months ended December 31, 2016:
 - Income from Product Transportation Services was increased by 2.9% from ₹ 1873 lakh to ₹ 1927 lakh on Y-o-Y basis.
 - Income from Hiring Construction Machineries was increased by 6.0% from ₹ 2487 lakh to ₹ 2637 lakh on Y-o-Y basis.
 - Income from Other Support Services increased by 1.8% from ₹ 2332 lakh to ₹ 2373 lakh on Y-o-Y basis.





- Net Profit during the nine months ended December 31, 2016 was ₹ 912 lakh as compared to ₹ 1264 lakh on Y-o-Y basis.

RIIL continues to provide infrastructure support services namely transportation of petroleum products and water through pipelines, construction machinery on hire and other support services to Reliance Industries Group, with a substantial portion provided to Reliance Industries Limited.

RIIL presently does not have any expansion plans on the anvil.
